REGULATION NO. 2006/34

**AMENDING UNMIK REGULATION NO. 2001/19 ON THE EXECUTIVE
BRANCH OF THE PROVISIONAL INSTITUTIONS
OF SELF-GOVERNMENT IN KOSOVO**

The Special Representative of the Secretary-General,

Pursuant to the authority given to him under United Nations Security Council resolution 1244 (1999) of 10 June 1999,

Taking into account United Nations Interim Administration Mission in Kosovo (UNMIK) Regulation No. 1999/1 of 25 July 1999, as amended, on the Authority of the Interim Administration in Kosovo,

Acting in conformity with the Constitutional Framework for Provisional Self-Government in Kosovo (UNMIK Regulation No. 2001/9 of 15 May 2001),

Having promulgated UNMIK Regulation No. 2001/19 of 13 September 2001 on the establishment of the Executive Branch of the Provisional Institutions of Self-Government in Kosovo, and UNMIK Regulation No. 2002/5 of 4 March 2002, UNMIK Regulation No. 2005/15 of 16 March 2005, UNMIK Regulation No. 2005/53 of 20 December 2005, UNMIK Regulation No. 2006/19 of 22 April 2006 and UNMIK Regulation No. 2006/26 of 27 April 2006, amending UNMIK Regulation No. 2001/19,

Acting at the request of the Government to establish an Executive Agency for European Integration as reflected in a communication from the Prime Minister dated 7 April 2006,

For the purpose of amending section 2.1 of UNMIK Regulation No. 2001/19 in order to reflect the establishment of an Executive Agency for European Integration,

Hereby promulgates the following:

Section 1
Amendments

As of the date on which the present Regulation enters into force, UNMIK Regulation No. 2001/19, as amended, shall be further amended as follows:

- (a) Section 2.1 shall be revised to read:

The Office of the Prime Minister

2.1 The Office of the Prime Minister shall have a unit which includes political advisers referred in section 1.4 and shall also encompass the following organizational units having responsibilities and functions as set out in Annex I to the present Regulation:

- (a) Office of the Deputy Prime Minister;
- (b) Government Coordination Secretariat;
- (c) Office of Legal Support Services;
- (d) Office of Public Information;
- (e) Advisory Office on Good Governance, Human Rights, Equal Opportunity and Gender;
- (f) Office for Coordination of International Cooperation and Regional Dialogue;
- (g) Office for Public Safety; and
- (h) Senior Public Appointments Committee.

2.1.1 In addition, there shall be an Agency for European Integration having the status of an Executive Agency organizationally attached to the Office of the Prime Minister, which shall carry out its responsibilities and functions pursuant to UNMIK Administrative Direction No. 2006/6 of 15 May 2006 Implementing UNMIK Regulation No. 2001/19 on the Executive Branch of the Provisional Institutions of Self-Government.; and

- (b) In Annex 1, section H shall be deleted and the current section I shall be renumbered as section H.

Section 2
Entry into Force

The present Regulation shall enter into force on 22 May 2006.
