**AMENDING UNMIK REGULATION NO. 2001/19
ON THE EXECUTIVE BRANCH OF THE PROVISIONAL
INSTITUTIONS OF SELF-GOVERNMENT IN KOSOVO**

The Special Representative of the Secretary-General,

Pursuant to the authority given to him under United Nations Security Council resolution No. 1244 (1999) of 10 June 1999,

Taking into account United Nations Interim Administration Mission in Kosovo (UNMIK) Regulation No. 1999/1 of 25 July 1999, as amended, on the Authority of the Interim Administration in Kosovo,

Acting in conformity with the Constitutional Framework for Provisional Self-Government in Kosovo (UNMIK Regulation No. 2001/9 of 15 May 2001),

Having promulgated UNMIK Regulation No. 2001/19 of 13 September 2001, as amended, on the establishment of the Executive Branch of the Provisional Institutions of Self-Government in Kosovo, UNMIK Regulation No. 2002/5 of 4 March 2002 amending UNMIK Regulation No. 2001/19, and UNMIK Regulation No. 2005/15 of 16 March 2005 amending UNMIK Regulation No. 2001/19.

Taking into account consultations with the political parties and coalitions leading to formation of the Government following the elections of 17 November 2007, and related decisions taken by the Assembly of Kosovo during its inaugural session on 9 January 2008,

For the purpose of amending sections 1 and 2 of UNMIK Regulation No. 2001/19 and its Annex I, in order to reflect the addition of the post of a second Deputy Prime Minister,

Hereby promulgates the following:

Section 1
Amendment

As of the date on which the present Regulation enters into force, UNMIK Regulation No. 2001/19 shall be amended as follows:

(a) In the first sentence of section 1.2.1, the phrase “a Deputy Prime Minister” shall be replaced by the phrase “up to two Deputy Prime Ministers.” Subsequently, the phrase “Deputy Prime Minister” shall be replaced by the phrase “Deputy Prime Ministers” throughout.

(b) In section 1.2.2, the phrase “the Deputy Prime Minister” shall be replaced by the phrase “a Deputy Prime Minister.”

(c) In sections 1.2.3, 1.4, 2.1(a) and in Annex I, in the heading and text of part A, the phrase “the Deputy Prime Minister” shall be replaced by the phrase “the Deputy Prime Minister(s).”

Section 2
Applicable Law

The present Regulation shall supersede any provision in the applicable law that is inconsistent with it.

Section 3
Entry into Force

The present Regulation shall enter into force on 14 January 2008.
