**REGULATION NO. 2008/9**

**ON**

**AN AMENDMENT TO THE CONSTITUTIONAL FRAMEWORK  
FOR PROVISIONAL SELF-GOVERNMENT**

The Special Representative of the Secretary-General (SRSG),

Pursuant to the authority given to him under United Nations Security Council resolution 1244 (1999) of 10 June 1999,

Taking into account United Nations Interim Administration Mission in Kosovo (UNMIK) Regulation No. 1999/1 of 25 July 1999, as amended, on the Authority of the Interim Administration in Kosovo and UNMIK Regulation No. 2001/9 of 15 May 2001 on the Constitutional Framework for Provisional Self-Government in Kosovo (the Constitutional Framework for Provisional Self-Government),

Having considered a communication from the President of the Assembly of Kosovo, dated 7 February 2008, submitting to the SRSG a motion adopted by the Assembly with the required two thirds majority on 31 January 2008 for amendment of section 9.1.7 of the Constitutional Framework for Provisional Self-Government,

Acting in conformity with section 14.3 of the Constitutional Framework for Provisional Self-Government,

Hereby promulgates the amendment to the Constitutional Framework for Provisional Self-Government set out in the Annex to the present Regulation.

The present Regulation shall enter into force on 8 February 2008.

ANNEX**AMENDMENT TO THE CONSTITUTIONAL FRAMEWORK  
FOR PROVISIONAL SELF-GOVERNMENT**

**Section 9.1.7 of the Constitutional Framework for Provisional Self-Government shall be amended as follows:**

- (i) The opening sentence shall read:

“9.1.7 The Assembly shall have a Presidency consisting of nine Assembly members who shall be selected as follows:”;

- (ii) A new subparagraph (e) shall be added after the existing subparagraph (d) as follows:

“(e) One member shall be appointed by the party or coalition having obtained the fifth highest number of votes in the Assembly elections;”;

- (ii) The existing subparagraphs (e) and (f) shall be renumbered as (f) and (g).

Consequently, section 9.1.7 shall read as follows as of 8 February 2008:

**“9.1.7 The Assembly shall have a Presidency consisting of nine Assembly members who shall be selected as follows:**

(a) Two members shall be appointed by the party or coalition having obtained the highest number of votes in the Assembly elections;

(b) Two members shall be appointed by the party or coalition having obtained the second highest number of votes in the Assembly elections;

(c) One member shall be appointed by the party or coalition having obtained the third highest number of votes in the Assembly elections;

(d) One member shall be appointed by the party or coalition having obtained the fourth highest number of votes in the Assembly elections;

(e) One member shall be appointed by the party or coalition having obtained the fifth highest number of votes in the Assembly elections.

(f) One member shall be appointed from among the members of the Assembly belonging to those parties having declared themselves representative of the Kosovo Serb Community; and

(g) One member shall be appointed from among the members of the Assembly belonging to parties having declared themselves representative of a non-Kosovo Albanian and non-Kosovo Serb Community. The method for appointing this latter member shall be determined by members of the Assembly belonging to these same Communities.”
